Sub: To furnish the consolidated amount due and payable to each of the petitioners in the entire batch (category-wise) of writ petitions in respect of University of Delhi as well as its constituent colleges.


Dear Sir,

With reference to the MHRD letter cited under reference no (2), it is to inform that the Hon'ble High court of Delhi vide order dated 1.5.2017 cited at reference no.(1) has directed the Delhi University as well as its constituent colleges to intimate the UGC and MHRD the amount due and payable to each of the petitioners in the entire batch of writ petitions or LPA which have been allowed by virtue of order dated 24th August, 2016 passed by the Division bench in LPA No.410/2014 within a period of four weeks.

As directed by the Hon'ble High Court of Delhi, the pension liability (Gross pension) of the petitioners of the various colleges have already been finalized by the University of Delhi and sent to the respective colleges. The respective colleges will calculate the net pension liability of the individual petitioners from the date of retirement up to 30.4.2017 after adjusting the CPF (Employer contribution), if any, along with the 8% simple interest and the same is being submitted directly to the UGC by the colleges concerned since all the details are available in the colleges only.

As far as the petitioners of the University of Delhi are concerned, it is to mention that the total number of petitioners from the University of Delhi is 8 (Eight). Out of which, 3 (Three) petitioners are still in service and the net pension liability for the remaining 5 (Five) petitioners whose pension liability required to be deposited in the court has already been sent to the UGC/MHRD vide University letter dated 31.5.2017 a copy of which is enclosed herewith. It is pertinent to mention that the total amount of pension liability of the individual petitioners have been calculated up to 30.4.2017 from the date of retirement and the total amount required to be deposited in the Hon'ble high Court of Delhi for the 5 (Five) petitioners as listed in the annexure works out to Rs. 1,25,27,534/-.

Considering the above, compilation of the details of pension liability of the petitioners of the each college is not only time consuming but deviation from the order of the Hon'ble High Court of Delhi as well. However, University of Delhi will write to the Principals of the affiliated colleges to submit the total pension liability clearly indicating the net pension liability to be paid to the each petitioner category-wise to avoid any ambiguity in the matter.
