

**Ting of the NOTICE FOR LL.B. ADMISSION**  
**(In compliance with the order passed by the High Court of Delhi**  
**dated 26.09.17 in W.P.(C) 5118/2017)**

Date: 28<sup>th</sup> September 2017

As per the above order, Faculty of Law, University of Delhi has been directed by the High Court of Delhi to admit students on supernumerary seats over and above the sanctioned strength of 2310 seats in LL.B. Hence, additional admissions are being announced to fulfil the seats that have fallen vacant as a consequence of adding the supernumerary seats to the total of 2310 seats.

Counselling for additional seats will take place on 3<sup>rd</sup> October 2017 at Umang Bhawan, Faculty of Law (New Building), University of Delhi. All candidates as per the schedule given below are required to report at 11:00 AM sharp.

The counselling is strictly for those applicants who fall within the range of marks as notified below. The candidate is required to appear for counselling in person. Applicants are required to bring all the necessary original documents required for LL.B. admissions notified by University, failing which the admission will not be granted. Please check DU PG Admission website, [http://www.du.ac.in/du/uploads/Admissions/2017/PG/27072017\\_List.pdf](http://www.du.ac.in/du/uploads/Admissions/2017/PG/27072017_List.pdf), for the list of required documents. The list is also provided at the end of this notice.

The candidates will be admitted strictly according to their merit in the entrance test against the increased vacant seats as per the Court order.

The candidates having the following marks in the LL.B. Entrance Test in the respective categories are required to report at the above said time and place.

**Kind Attention:** Those eligible candidates whose admission was cancelled due to non submission of required documents by 28<sup>th</sup> August 2017 are also eligible for scheduled counseling if they fulfill the conditions of submitting the required original documents.

**This call does not guarantee admission in LL.B. programme as number of applicants called for the counselling is more than the seats vacant in the course. The admission will be strictly on the basis of merit among the candidates reporting for admission and the availability of seats in the Centre in their category.**

**The candidates will be allowed to pay the fee online till 11:59 pm of 6<sup>th</sup> October 2017 failing which their admission will be cancelled. No further time will be given to pay the fee.**

- 8. OBC (Non-Creamy Layer) Certificate (in the name of the Candidate) issued by competent authority**
- 9. In case the OBC Certificate is older than 1st April 2016, then a proof for the Non Creamy Layer Status.**
- 10. Migration Certificate: Required for those students who have passed qualifying examination from outside Delhi University**
- 11. At least two passport size self-attested photographs.**
