A meeting of the Committee on Medals, Prizes and Scholarship was held on 18<sup>th</sup> November, 2016 in the Committee Room of the Dean of Colleges at 2.30 p.m. to discuss about the institution of two Gold Medals to be introduced from the year 2017. The original minutes of the meeting are enclosed at Flag 'A' and Flag 'B'.

The Pro-Vice Chancellor, Prof. J.P. Khurana chaired the meeting.

Following members attended the meeting:

The committee had a detailed deliberation on the following:

1. Letter received from Prof. Kapil Kapoor, Chairman, India Policy Foundation dated 18<sup>th</sup> November, 2016 to institute a Gold Medal in memory of Pt. Deendayal Upadhyaya.

The committee unanimously resolved to institute the Gold Medal under the category "B.A. (Honours) in Political Science with 1<sup>st</sup> Division and highest marks obtained in Indian Political Thought as one of the papers of the Course". Flag 'A'

A communication received from Shri Mukul Rohatgi, Senior Advocate, Supreme Court of India dated 18<sup>th</sup> November, 2016 to institute a Gold Medal in memory of his father Late Justice Avadh Behari Rohatgi, who was an alumnus and faculty member of the University of Delhi.

The committee unanimously decided to institute the Gold Medal under the category "LL.B. with 1<sup>st</sup> Division and highest marks obtained in Indian Constitutional Law as one of the papers of the course". Flag 'B'

The committee further resolved that information should be sent to Prof. Kapil Kapoor, Chairman, India Policy Foundation and Shri Mukul Rohatgi to send Rs. 10 Lakhs each as donation for institution of the Gold Medals.

Accordingly, the announcement for institution of Pandit Deen Dayal Upadhyaya Memorial Gold Medal and Late Justice Avadh Behari Rohtagi Gold Medal was made in the 93<sup>rd</sup> Annual Convocation, 2016 held on 19<sup>th</sup> November, 2016. Flag 'C'.

If approved, the note along with the recommendations of the Committee may be forwarded to the Assistant Registrar (Scholarship) for completing the requisite formalities in the matter and thereafter for preparing the agenda item to be placed in the ensuing Academic Council/Executive Council meeting.
