- The firm should submit a request letter along with their copy of registration certificate for obtaining tender form. (registration certificate is not applicable for VPCI contractor)**
- The rates, amount and total should be in words and figures also.**
- The overall lowest amount will be considered as L1.**
- It is mandatory to quote the complete tender enquiry number with complete address on the envelope otherwise the tender will be rejected.
- The work should be completed within 45 days from the date of award of contract/site.
- The quotations in a sealed cover shall be put in the Tender Box available in dispatch section, 3<sup>rd</sup> floor of Multi-storied Building on or before **22.08.2014 at 1.00 PM** and will be opened on same day at **3.00 PM** at Committee Room at Administration Block (3<sup>rd</sup> floor).
- The site should be inspected on 21.08.14 at 5.00 PM. The proof of site inspection should be produced along with the tender. Otherwise the tender will liable for rejection.
- An EMD of value of Rs. 27345.00 should be submitted along with the tender in the form of Demand Draft in favor of “Director – V. P. Chest Institute”.
- The successful tenderer has to submit a Performance Guarantee amount equals to 5% of quoted amount in the form of Demand Draft in favour of “Director – V. P. Chest Institute”. The performance guarantee will be released after submission of completion certificate of work.
