

2. The Tender shall remain open for acceptance for one hundred and twenty (120) days from the date of opening of tenders by the Vallabhbai Patel Chest Institute (VPCI). The time limit for acceptance may be extended by VPCI at its discretion for such further period, as it may notify.
3. This tender document is not transferable. The tendered work, if awarded, is not transferable.
4. The successful tender has to submit a Performance Guarantee amount equal to 5% of quoted amount in the form of Demand Draft/FDR in favour of "Director - V.P. Chest Institute". The performance guarantee will be released after submission of completion certificate of work.
5. The site may be inspected in all work days & hours.
6. VPCI reserve the right to accept or reject any or all tenders without assigning any reason whatever in may be.
