**Pre-qualification criteria:**

1. Bidders should either be the original equipment manufacturer (OEM) /authorized dealer. In case the bidder is an authorized dealer, a letter of Authorization from OEM specific to this tender should be enclosed. In case the equipment is quoted by the Indian subsidiary of OEM, a certificate from the OEM should also be attached.
2. OEM should be internationally reputed Branded Company.
3. Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid.
4. If an authorized dealer submits a bid on behalf of Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM for the same tender.

5. The Bidder should attach the proof of deployment of three similar products of same make (of higher or lesser storage capacity) in last three years in the Govt / Education sector.
6. The bidder should have an average annual turnover of 1 crore during last 3 financial years.
7. The bidder must not be blacklisted by Delhi University. A certificate or undertaking to this effect must be submitted.
8. Non-compliance of pre-qualification criteria will lead to rejection of bid.

**Prices:**

1. The total cost must include packing, delivery, installation and after sales maintenance at Department of Biophysics, University of Delhi South Campus, New Delhi.
2. The prices should be quoted only in the format as provided in with the tender and in INR only.
3. No manual bid will be accepted. All quotations (both technical and financial) must be submitted through CPP E-procurement portal.
4. The offer/bid should be inclusive of all the taxes. However, prices should be quoted with the reduced 5% GST rate, as Delhi University is exempted from higher GST rates and necessary certificate will be issued on demand.

**Two Bid System:**

1. Separate Technical and Commercial bids should be submitted. The Technical bid should contain the documents mentioned under the section Pre-qualification criteria. The financial bid should contain only the price details.
2. **No manual bid will be accepted. All quotations (both technical and financial) must be submitted through CPP e-procurement portal (Tender Reference Number: UDSC/BioPhy/2019-20/446 Tender ID: 2019\_DU\_490716\_1).**
3. **Technical bid** must contain a technical compliance sheet. Technical compliance sheet may contain page numebr of a published catalogue/operating manual/manufacture wesite as proof for compliance with the instrument. Relevant copies of catalogue/operating manual/maufacture webiste pages that have been listed as proof should be attached.
4. **Financial Bid** should have price in the form of BoQ\_biophysics\_201920\_446.xls The Financial Bid format is provided as BoQ\_biophysics\_201920\_446.xls along with this tender document at <https://eprocure.gov.in/eprocure/app>. Bidders are advised to download this BoQ\_biophysics\_201920\_446.xls as it is and quote their offer/rates in the permitted column and upload the same in the commercial bid. Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and tenderer is liable to be banned from doing business with University of Delhi.

**Payment:**

1. Payment shall be made against delivery, inspection, successful installation, commissioning and acceptance of the equipment at Department of Biophysics, University of Delhi South Campus in good condition and to the entire satisfaction of the purchaser.
