1. **The firm should submit a request letter along with their copy of registration certificate for obtaining tender form. (registration certificate is not applicable for VPCI contractor)**
2. **The rates, amount and total should be in words and figures also.**
3. **The overall lowest amount will be considered as L1.**
4. It is mandatory to quote the complete tender enquiry number, name of work, Tender due date & time with complete tenderer address over the envelope otherwise the tender will be rejected.
5. The work should be completed within 30 days from the date of award of contract.
6. The quotations in a sealed cover shall be put in the Tender Box available in dispatch section, 3rd floor of Multi-storied Building on or before **07.12.2015 at 1.00 PM** and will be opened on same day at **2.30 PM** at Committee Room at Administration Block (3rd floor).
7. The successful tenderer has to submit a Performance Guarantee amount equals to 5% of quoted amount in the form of Demand Draft in favour of “Director – V. P. Chest Institute”. The performance guarantee will be released after submission of completion certificate of work.
8. The site may be inspected in all working days & hours.
9. The tenderer has to submit a copy of their registration certificates, their work experience profile and the documents related to the eligibility criteria as mentioned above along with the Tender. Otherwise, the tender of the form should be rejected.
