  - Envelope 3: **“EMD draft for WACOM Pen and Touch Display”**
- The tender must reach Cluster Innovation Centre (CIC), Room No. 308, 3<sup>rd</sup> Floor, University Stadium, G.C. Narang Marg, University of Delhi North Campus, Delhi – 110 007 by **17:00hrs, 23<sup>rd</sup> February 2016**. Delay due to any reason will not be entertained.
- The categories of items and quantity indicated are tentative. CIC, University of Delhi, reserves the right to increase or decrease the quantity or delete some or all of the items.
- Vendors can bid for one or more items out of the list. EMD amount is to be computed by combining the EMD items for which bid is submitted. EMD **be submitted** in the form of Bank Draft / Banker’s Cheque drawn from a scheduled bank in favor of **“The Registrar, University of Delhi, Delhi”**, payable at Delhi. EMD draft will be returned to the unsuccessful bidders within 3 weeks from the date of opening of the price bids.
- The total cost inclusive of all applicable taxes and duties must be clearly mentioned both in figures and words in the price bid, and this will form the basis of price comparison for the award of the tender. The price bid must separately mention the cost for standard warranty and for a warranty extended to three years.

6. **The technical bids will be opened at 17:00hrs, 24<sup>th</sup> February 2016. The financial bids will be opened at 14:00hrs, 26<sup>th</sup> February 2016. Venue: 2<sup>nd</sup> Floor Committee Room, University Stadium, University of Delhi North Campus.**
7. **Performance Bank Guarantee:**
  - a. If the warranty and onsite service is to be provided by the OEM during the warranty period, a certificate to that respect has to be issued by OEM to The Director, Cluster Innovation Centre, University of Delhi, G. C. Narang Marg, Delhi – 110007.
  - b. In absence of the above certificate from OEM, vendor will have to submit a Performance Bank Guarantee of the value equivalent to 10% of the total contract value prior to receiving the purchase order and it must be valid six months beyond the period of warranty.
8. The rates approved shall remain valid for 6 months from the date of opening of the price bid and the vendor will be bound to accept repeat orders at the same price during this validity period. If the OEM withdraws the approved model, this has to be informed to CIC directly by the OEM.
9. Corrigendum or change in tender schedule, if any, will be posted on the university and CIC website only.
