**(Scholarship Cell)**

**"SHRI KHUSHI RAM SCHOLARSHIP"**

1. There shall be three scholarships \*known as "Shri Khushi Ram Scholarship" each of the value of ₹ 100/-p.m. to be awarded out of the annual income accruing from the Endowment Fund of ₹ 81,200/-\*\* endowed by Shri Khushi Ram, 16/22, W.E.A. Karol Bagh, New Delhi.
2. The Scholarship shall be tenable for a period of three years, renewable yearly on the basis of satisfactory performance of the awardee.
3. The Scholarship shall be awarded to meritorious and needy students who joins the first year of the Bachelor's Degree Courses in any of the subjects under the Faculties of Arts, Science, Social Sciences, Mathematics and Music & Fine Arts.
4. a. No student shall be eligible for this scholarships if he already holds a scholarship awarded by the University of Delhi or any other University or the Central Government, or any State Government or Private Body, other than Freeship.  
  
b. In case any scholar accepts any other scholarship/financial assistance from any other source, he/she shall be required to refund the amount received by him/her on this account from the date he/she accepts the other scholarship/financial assistance.
5. If it should appear to the University at any time during the tenure of the award that the scholar has failed to make satisfactory progress or has been found guilty or gross misconduct or has been irregular to in attendance, he/she shall, after due warning in writing, be reported by the Principal/Head of his/her College/Department to the Academic Council which may reduce, suspend or withdraw the Scholarship.
6. The scholarship shall be awarded by the Academic Council on the recommendations of the Selection Committee constituted as follows:-
  - i) The Dean, Faculty of Arts (Chairman)
  - ii) The Dean, Faculty of Science
  - iii) The Dean, Faculty of Social Sciences
  - iv) The Dean, Faculty of Mathematics
  - v) The Dean, Faculty of Music and Fine Arts
7. Applications for the scholarships, in the prescribed form available from the office of the Registrar (Scholarship Cell) should reach the Registrar, University of Delhi, Delhi – 07, through the Principal/Head of the Institution concerned by the date mentioned in the Notification issued by the Registrar in this behalf.
8. The payment of the scholarship amount shall be made to the scholar through the Principal of the college/Head of the Department from may each year on presentation of a bill and a certificate to the effect that during the period covered in the bill, the scholar was not receipt of in any other scholarship/financial assistance from any other source.
9. The unutilised amount in any year shall be added to the corpus of the endowment fund.
